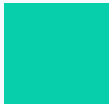

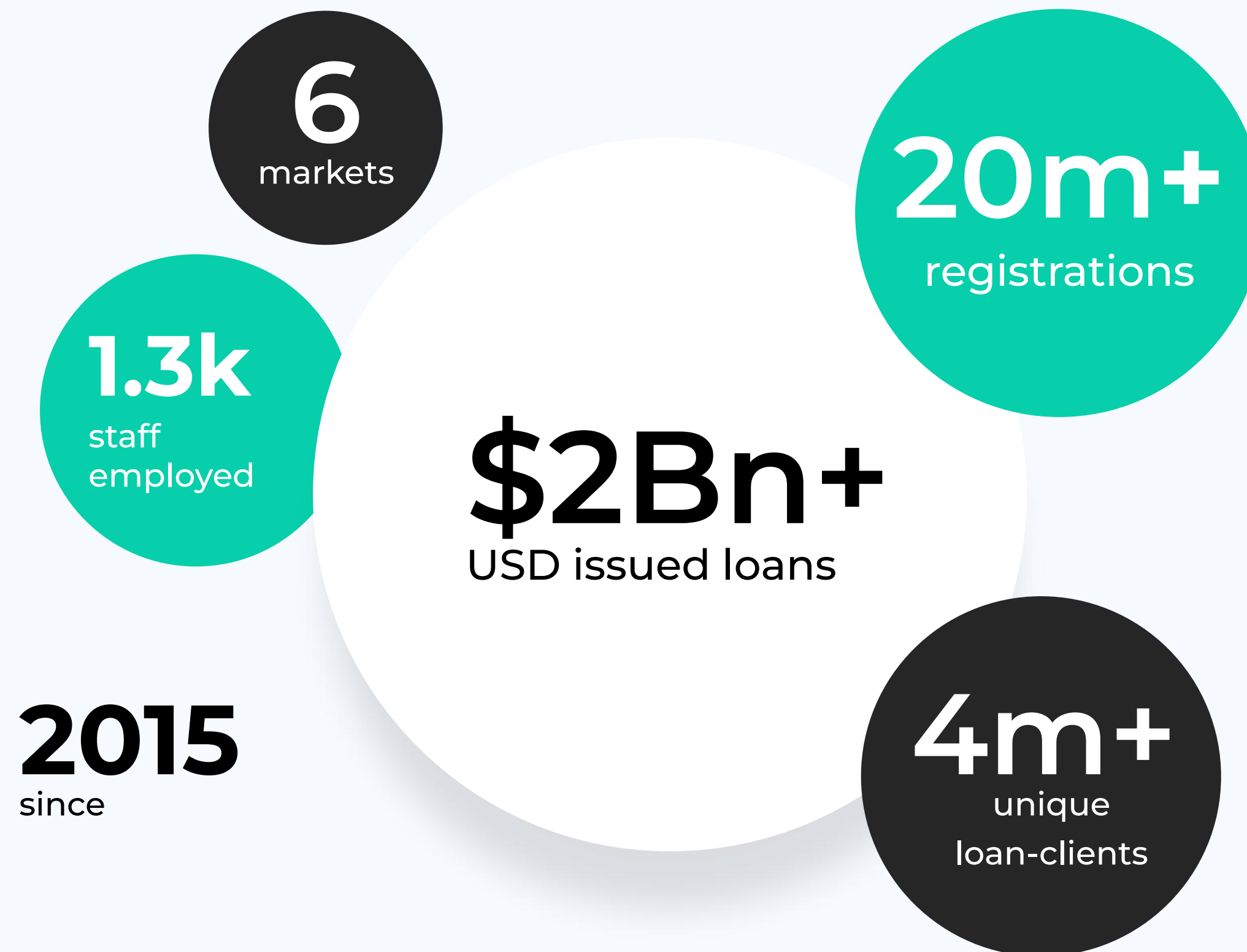

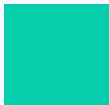

The revenue* for 2024 amounted to USD 202.3 M. Net profit stood at USD 0.6 M.



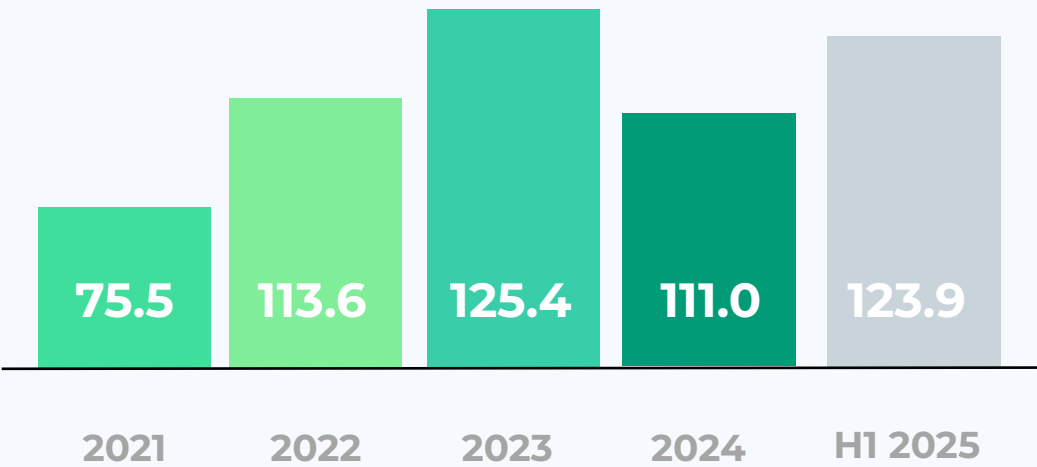
In 2025, we aim to grow net profit and expand our lending activities.

Our priorities include:

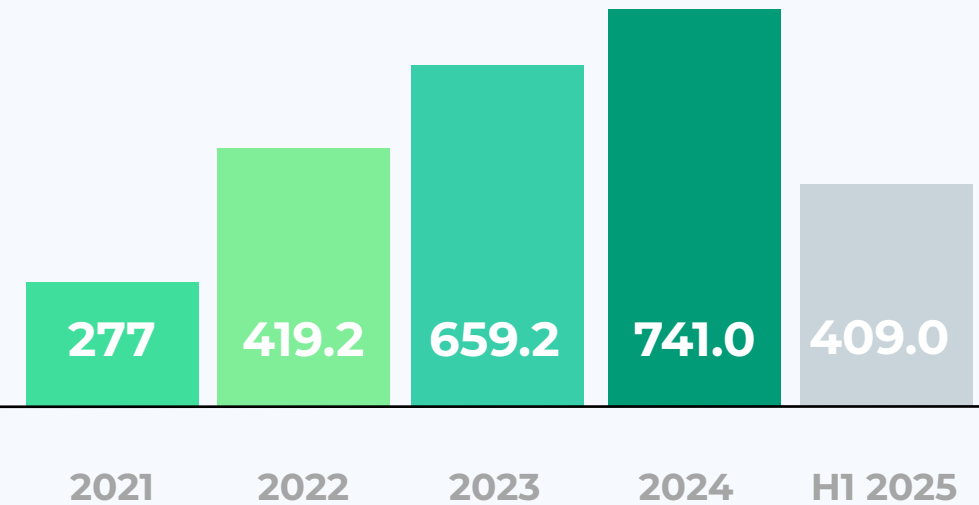

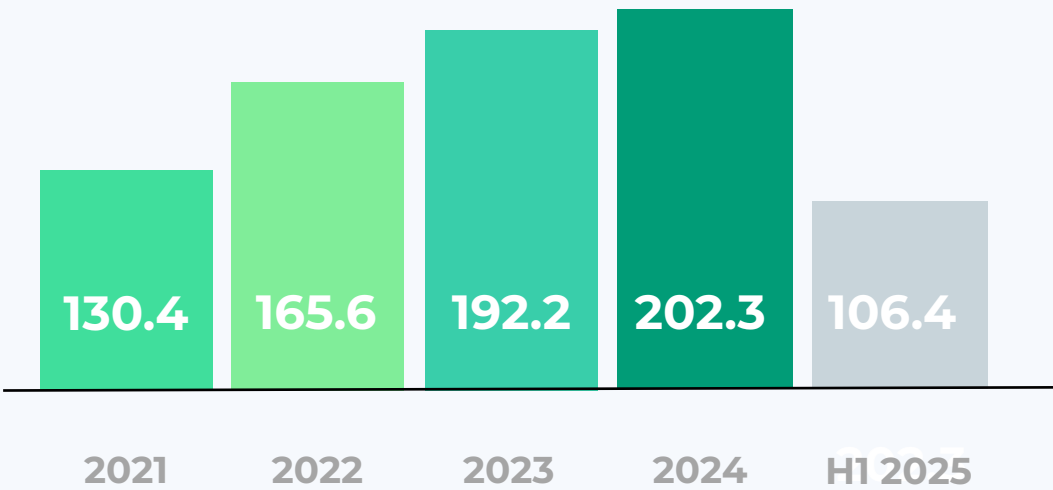
Total assets, M USD



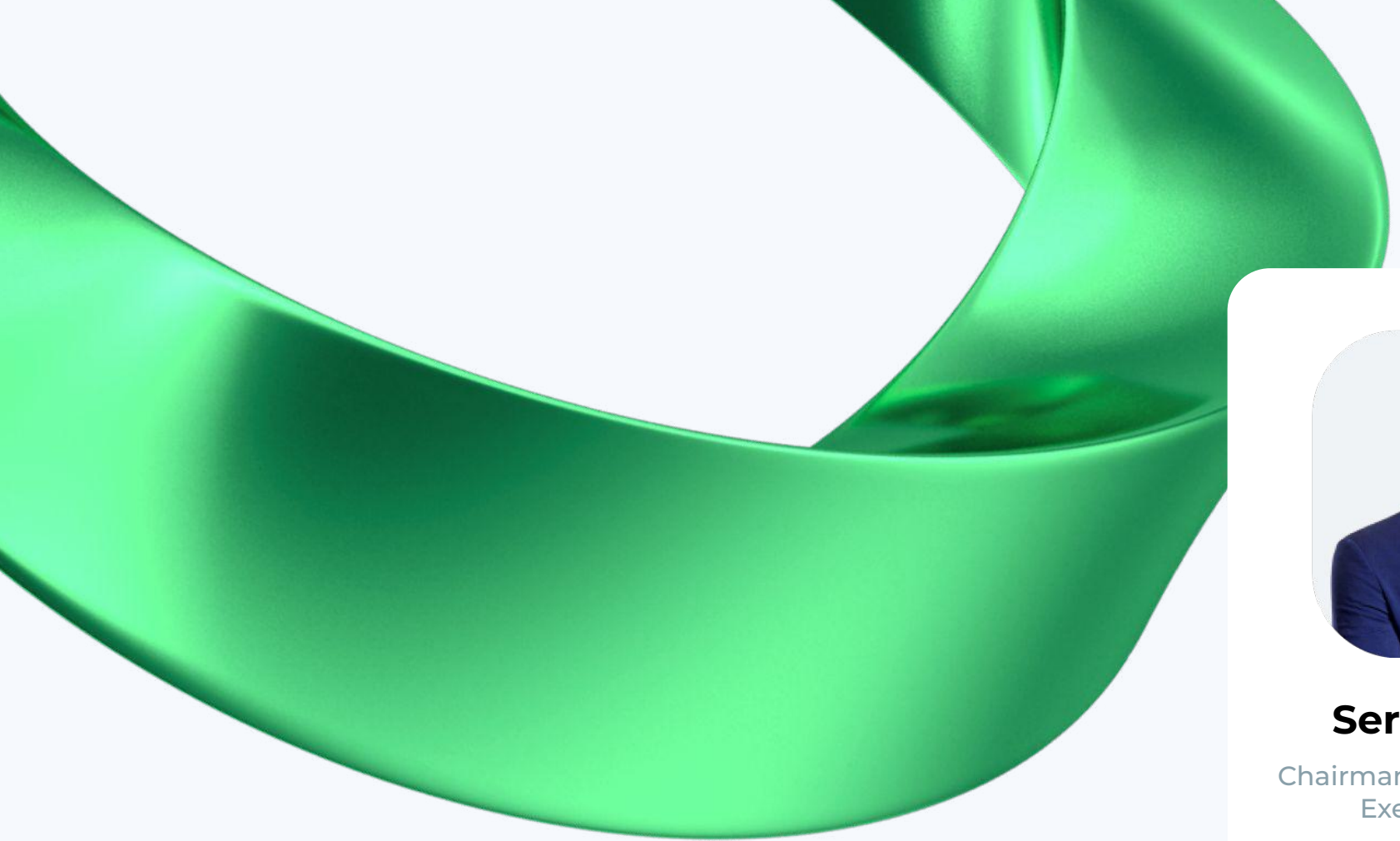
Loans issued, M USD

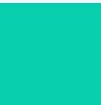
